

Business:

Call to Order: President Rachael Thompson called the meeting to order at 12:01 p.m. The Pledge of Allegiance and Zonta Blessing followed the call to order. Pin Penalty was invoked.

Motion to approve the agenda was made by Kati Blum, seconded by Belinda Ryan. Motion was approved.

Consent Agenda:

Minutes of Business meeting December 2024 Treasurer's reports for December 2024

Joel Peitz made a motion to approve the consent agenda as published in the ZoNews. Kati Blum seconded the motion. Motion approved.

Correspondence & Requests: Found in Zo News. This issue included future meeting dates and locations, information on increase in dues, and ballot for Vice President.

Business:

Special Election: Nomination Committee has submitted a ballot for the vacant Vice President position that resulted from Rachael Thompson moving into President position. Lyndsey Stram's name is the sole name on this ballot. Bylaws were reviewed to ensure that she may serve in the Vice President position while retaining her Treasurer position until the end of her term and the next regular election. The bylaws allow her to have both positions. Laurie Oppel made motion to elect Lyndsey Stram to Vice President position. Kati Blum seconded the motion. Motion was approved. Nomination Committee will be looking for members to fill four positions in the next election: Treasurer, Secretary and two board members. Members can nominate a member or self-nominate for the position. Committee is hoping to finalize the ballot by the end of February.

Dues: The updated increase in club dues for next year was posted in the ZoNews. The amount will simplify and provide more monetary support for local items that are needed when installing new members. Mary Garding moved to approve the new club dues amounts. Mary Robak-Saari seconded the motion. Motion was approved. It was noted that the Treasurer will be sending out statements earlier this year and expecting responses by mid-March. Included with the statement will be the opportunity to contribute to the planned service projects for the next year. This includes the taco event in September and cookie decorating in December at Anna Marie's Alliance. This makes it easier and simpler to donate to these events.

Calendar of Events: Invites to important events have been sent by email. Some specific events were noted:

- April 12th, Earth Day. Someone is needed to coordinate the event. If no one volunteers, we will not be able to participate. Last year \$500 was awarded the club for doing the event and an additional \$1000 for being judged as winning zone. Tasks in this assignment include submitting the application and then organize volunteers to participate. It was noted this date does conflict with Area meeting in Whampaton for anyone planning to attend.
- April 24th, Spring Speaker Event. This will be held at the St Cloud Library and will be open to the public. Agenda will be speakers from local non-profits including Terebinth, Crisis Nursery, Central Minnesota Sexual Assault Center and Anna Marie's Alliance.
- May 7th, Annual Meeting. This will be held at Brickyard in Clear Lake. There will be a short meeting prior to the social event.
- October- Fall event. Details are still pending.

Mini Grant Nominations: A nomination form was added to ZoNews and available in paper today. This is for a special one-time only grant for this year of between \$500 and \$1000. These nomination forms will be submitted to the Finance Committee by mid-February. The Finance Committee will send out full application forms to the nominated agencies. The submitted applications will be reviewed, and the Finance Committee will make a recommendation back to the club for the grants.

Christmas House: Sponsor donations were increased this year resulting in a very successful Christmas House. Committee is looking for a house for next year's event. Members are welcome to this committee along with Kayaking Committee. This last event is scheduled for August 3rd.


